If you do not meet the minimum monthly trading requirement, the monthly fee will be deducted from your trading account the first business day of the following month. Only one eSignal monthly subscription will be provided per trading account and once your account is closed your eSignal subscription will be cancelled. In order to receive the eSignal subscription you must also complete, sign and return the eSignal Personal Data Sheet.
